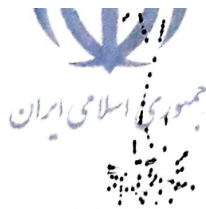
**“Agreement of Extending Academic and Industrial
Cooperation”**

Following the meeting held at Iran University of Science and Technology in Tehran on the 16th of May 2016, between the committees representing **the School of Railway Engineering** and **Dnipropetrovsk National University of Railway Transport** in Ukraine, the following articles conversed and jointly agreed.

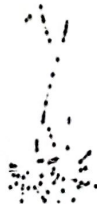
1. Both parties willingly approved the extension of the previous Memorandum of Understanding of April 24th 1999 and would like to remain in favor of holding the whole contents of the mentioned MOU. A copy of the said MOU is also attached to this document.

2. The mutual cooperation covers many forms of activities from promoting academic and enterprise cooperation through “twinning” and networking among other academic institutions and industries to permit the access, transfer and adaptation of knowledge more nationally, regionally and globally.

3. The cooperation includes various aspects of academic and enterprise issues. Some items of more attention are as follow:

- Mutual academic supervision of postgraduate students at both universities.
- Holding and attending international scientific meetings and conferences in rail transportation.
- Cooperation in rail test rigs in both laboratory and field scales.
- Mutual research endeavor in national and international rail research and innovative projects
- Both student and professor exchange in between our universities.
- Organizing coordinated teaching activities.
- Joint development of academic types of publications of common interests for both parties.

4. To facilitate the execution of this agreement each party will appoint a faculty coordinator whose more important duties will be, the following:





- Coordinate the activities developed under the terms of this agreement and be in direct communication with the agreement coordinator of the other university.
- Coordinate with the Office for International Relations, of the corresponding university, for all items concerning with this agreement.
- Collect and present new ideas for extending the mutual cooperation.

5. This agreement is approved in accordance with the provisions of both parties and will be valid, from the date of signing for a period of five years. It will be renewed automatically every 5 years. Either party may terminate it, by official, written notification delivered with at least **six months of anticipation**. In case of early extinction of the agreement, the mutual projects will continue up to the ending, without affecting the commitments undertaken by parties involved.
