

MEMORANDUM OF UNDERSTANDING

Between

**Dnepropetrovsk National University of Railway Transport named after
Academician V. Lazaryan**

And

**The International University of Logistics and Transport in Wrocław, Poland
(IULT)**



This agreement is established on February 1, 2015 between Dnepropetrovsk National University of Railway Transport named after Academician V. Lazaryan located in Dnepropetrovsk, Ukraine and The International University of Logistics and Transport in Wrocław, Poland, collectively referred herein as “the Parties“, to express common interest to establish a long-term bilateral cooperation, therefore for and in consideration of the mutual promises, responsibilities and representations contained herein, the Parties hereby agree as follows:

Article 1. Representations and Warranties

- a) **Dnepropetrovsk National University of Railway Transport named after Academician V. Lazaryan** represented by Prof. Olexandr Pshinko-Rector, represents and warrants that is a duly organized non-profit institution in good standing under the laws of Ukraine; that it has the corporate authority to enter into the Agreement; and that entering into and performing the Agreement with The International University of Logistics and Transport in Wrocław does not violate any law, rule, or regulation governing universities operating within Ukraine.
- b) **The International University of Logistics and Transport in Wrocław, IULT**, non-public University seated in ul. Sołtysowicka 19 b, 51-168 Wrocław, Poland, represented by Mr Janusz Pawęska – the Chancellor

Article 2. Scope of the Agreement

On the basis of friendship, the Parties wish to cooperate and support mutual activities in the following fields:

- a) Education – to develop study programs and to create joint educational programs and exchange educational experience;
- b) Research – to establish joint research projects and research programs;

- c) Social and Cultural – to strengthen and to develop social and cultural contacts and understanding of national cultures of the Parties;
- d) Exchange of Students, Academic Staff and Scientists – to support mobility of students and teachers, study and lecture visits.

Article 3. Finance

- a) This Agreement does not give rise to any financial obligation.
- b) The Parties will extend to each other the most favorable treatment.

Article 4. Term of the Agreement

This Agreement is established for an indefinite period.

Article 5. Notices and Contacts

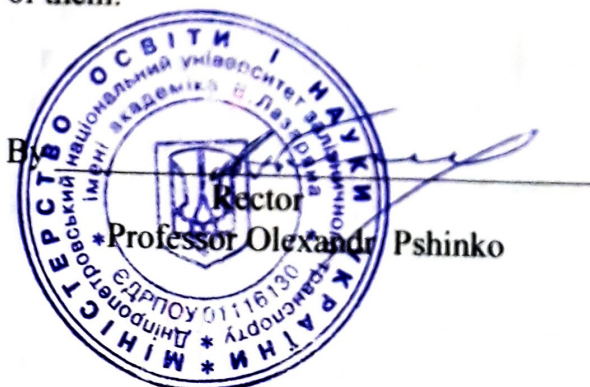
- b) Each Party will appoint a contact person and will inform the other Party about it. Should there be any change in the contact person, the Party of change will inform the other Party without hesitation.
